Client shall ensure that (A) 5 feet of room around designated location for pole (B) additional champagne classes are provided if party exceeds 12 guest (C) guest are provided with adequate address and directions to venue (D) payment balance is surrendered once entertainer arrives at venue (E) music system is available that plays CD's.

Entertainer shall ensure that: (A) 1 pole is available for every 15 guest (B) 2 poles will be at venue for 16 plus guest (C) ample champagne is at venue for one glass for each prepaid guest (C) guest learn a minimum of 8 sensual pole moves.

Entertainment Fee:

Entertainment fee is \$35 per person with a minimum of 10 people or \$350 for up to 10 people. Fees are charged as per everyone who physically participates as well as guest who only view entertainment. Fees includes a minimum of 1 hour of entertainment, glass of champagne for toasting purposes and adult goody bag for each guest that surrender payment prior to engagement date. Final number of guest attending engagement (whose payments have been received by hostess) must be communicated to entertainer no later than 10 days before engagement.

Rescheduling:

Rescheduling of engagements by the client for any reason shall result in forfeiture of 50% of deposit. Client rescheduling of engagement must be followed by updated contract within 24 hours of rescheduling. Engagements rescheduled less than two weeks prior to scheduled engagements shall result in forfeiture of entire deposit.

Cancellation:

Cancellation of the engagement by the client for any reason shall result in forfeiture of entire deposit. A client canceling the engagement by telephone must also verify that cancellation in writing (via dated mail or FAX) within 48 hours of verbal cancellation.

Travel Fee:

Entertainer will travel any distance but will only travel 30 miles (round trip) with no fee to engagement. Thereafter, client will be charged \$0.75 per mile starting at 10451 zip code.

Other Fee:

For parties that start later than agreed start time due to client's doing, must be compensated \$20 for every ½ hour.

Once number of guest is confirmed (above 10 guest) hostess is responsible for additional goody bags for guest who does not show up or participate. Goody bag cost is \$20 per bag. Money must be submitted at time of engagement unless otherwise arranged. If additional guest exceeds total number of guess confirmed, goody bags will not be provided and cost per guest will be charged which is \$35 per person.

I _____ confirm _____ guest who will be present at engagement.

Recording Of Engagements:

Recording of engagements is allowed with restrictions as to recording of entertainer. Entertainer must not be recorded at anytime during the event. Diamond Dejiior is not responsible for any legal actions arriving from recording guest at engagements. Diamond Dejiior does not agree to sales of recorded engagements.

Termination of Contract:

This contract shall automatically terminate without further notice at the end of engagement.

Assignment:

Neither Client nor Entertainer shall transfer, assign, hypothecate, encumber or in any other way transfer the Contract or any right or interest therein, voluntarily or involuntarily, without the written consent of the other party and any purported assignment or transfer in violation hereof shall be null and void.

Venue:

Venue for legal proceedings, if any, shall be in Bronx, New York.
